

- Most of the threat actors are targeting organizations for money; however, research notes that it's starting to impact patient outcomes including longer hospitalizations and increased patient deaths.
- Unprotected systems can be used to stage attacks against other targets.
- According to IBM, 62% of all cyber-attacks detected last year were targeted towards small and mid-sized organizations.
- A cybersecurity program should aim to help the organization:
 - Meet regulatory, audit, and legal requirements
 - Identify and manage cyber risk
 - Prevent cyber attacks from occurring when possible
 - Reduce or mitigate the impact of successful cyber attacks
 - Protect critical data and business processes
- A Cybersecurity Awareness Program includes: Technical Mitigations, Processes and Plans, Education along with "Care and Feeding." It requires program leaders, a cybersecurity champion, and a holistic approach,. Input for program must come from Senior Executives, Legal Counsel, Human Resources, Risk Management, Individual Business Units and Outside Vendors / Partners.

Kansas is included in the Central US region. The International ShakeOut Day is always the third Thursday of October (this year: October 21). While COVID-19 has brought many uncertainties and challenges, one thing's for sure: ShakeOut is still happening this year! As always, you can hold your #ShakeOut drill when and where you want. You can choose another date or several dates, and include people in multiple locations (home, work, or school), perhaps through video conferencing. Earthquakes happen all the time in Kansas, at this writing, Kansas has had 8 earthquakes in the past 7 days, 36 earthquakes in the past 30 days and 699 earthquakes in the past 365 days with the largest being a 2.5 earthquake in Solomon, Kansas. Recently, a Kansas county, was hit with a cyber attack. Initially, the county government offices were reassured of their data because they had established a back-up server. They were soon met with the realization that the attacker had already found the back-up server and was holding it for ransom as well The attacker easily found the back-up server as it was labeled, "Back-up Server." Best Practice: have a back-up server labeled with a name not easily identified and load another server named, "Back-up Server" with junk information.

- During a recent Joint Commission Survey, hospital floor staff were asked to identify policy and processes involved in COVID response. Best Practice: make sure everyone

knows the COVID practices and resources. During this same survey, the surveyor inspected the COVID unit processes and questioned visitors on PPE training practices. as last rites were being given to a patient who was at the end of life. **Best Practice**: make sure you have a policy in place to train visitors on highly infectious disease protection measures throughout the hospital.
