Mission Control App

Mission Control App has in the past been very useful to 30+ hospitals in Kansas for patient transfer. Now, the app has been secured by KDHE for all 124 hospitals in Kansas and is helpful in finding placement for patients. Mission Control calls hospitals to see if able to accept COVID patients. Currently, the app is transfer focused, but will eventually have other features added. The app will extend into the KC Metro area and cover part of the KC, MO area too. The app does not replace EM Resource which tracks bed capacity nor Teletracking via Health & Human Services.
